Purpose of appearance: Public Hearing - Zoning Ordinance Amendment - Solar Farms

The amendment as proposed has been reviewed by the Planning Board on several occasions dating back to December 2014. On July 16, 2015 the Planning Board provided a recommendation supporting the approval of the zoning ordinance amendment concerning solar farms. The amendment as presented includes language updates concerning setbacks, screening and fencing, lighting, glare, annual inspections, and decommissioning of solar farms. As per NC General Statutes and the Vance County Zoning Ordinance, the Planning Board is required to consider and provide a recommendation on any zoning ordinance amendments.

Following the Planning Board recommendation, the Board's Planning and Environmental Committee met on July 22 as directed by the full Board of Commissioners to provide an additional layer of review. During this meeting, the committee was agreeable to all provisions with the exception of setbacks. The recommendation from the Planning Board was for 100 foot setbacks on all sides, and it was felt that this would allow the use of existing foliage when it is available and serve to better reduce the visual impact of solar farms on neighboring properties. In the Planning and Environmental Committee review, they felt a compromise of a 100 foot setback on the front with a 50 feet setback on the side was sufficient. Additionally, the Planning and Environmental Committee recommended increasing the fee for Solar Farm Conditional Use Permits from \$250 to \$400 to accommodate the additional required inspections within the ordinance amendment.

Action Following the Public Hearing

In order to assist the Board, staff has provided the following options to be considered regarding the setbacks:

- 100 foot setback on all sides – Planning Board recommendation
- 100 foot setback on the front and 50 foot setback on the sides – Planning and Environmental Committee Recommendation
- Existing setbacks – 50 feet on the front, 25 on the side, and 35 on the rear within AR zoning areas.

Recommendation: Approve zoning ordinance amendment providing additional protections for solar farms inclusive of a 100 foot front setback and 50 foot side and rear setbacks.

Recommendation: Update the Planning and Development Department fee schedule increasing the conditional use permit fee from \$250 to \$400 for solar farms only.

ORDINANCE AMENDING THE VANCE COUNTY ZONING ORDINANCE TO PROVIDE ADDITIONAL PROTECTIONS FOR SOLAR FARMS

WHEREAS, the Board of Commissioners has asked staff and the planning board to review the county's solar farm regulations; and

WHEREAS, the Vance County Planning Board has reviewed the proposed amendments to the Vance County Zoning Ordinance, has determined them to be consistent with the land use plan, and has provided a recommendation for their approval.

WHEREAS, the proposed amendments provide additional protections for property owners and citizens of the county while maintaining an environment conducive to economic development; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, that:

- A. The amendments as presented are consistent with the county land use plan by encouraging development at a rate and in a pattern which can be efficiently and effectively served by existing and planned services and facilities. Additionally the amendments accommodate and allow economic development and growth while protecting the environment, public health and general welfare.
- B. The Vance County Zoning Ordinance be amended as follows (deletions as ~~striketroughs~~, additions shown as underlined text):
 - 1) AMEND Section 6.10 N Solar Energy Systems, Large Scale (Solar Farms) as follows to add additional safety protections pertaining to setbacks, reflectivity and decommissioning:
 1. Height: Systems, equipment and structures shall not exceed twenty-five (25) feet in height when ground mounted. Excluded from this height requirement, however, are electric transmission lines and utility poles. Roof mounted systems shall not exceed the maximum height for the applicable zoning district.
 2. Setback: ~~Active solar system structures must meet the following setbacks: Ground-mounted~~ Ground mounted solar energy systems as part of a solar farm shall have a setback for all equipment including fences a minimum of 100 feet from street rights-of-way and other property lines. The Board of Adjustment may reduce such setback requirement if the proposed or existing buffer is sufficient to screen the project from view from adjoining properties or public rights-of-way. meet the minimum zoning setback for the zoning district in which it is located.
 3. Screening and Fencing: ~~Adequate fencing shall be provided along the perimeter of the area (with all entrances gated) to prevent trespassing on the property.~~ Systems, equipment and structures shall be fully enclosed and secured by a fence with a minimum height of 8 feet. A thirty (30) foot vegetative buffer consisting of a compact evergreen hedge or other type of evergreen foliage shall be required along the entire perimeter of the facility. The buffer shall be planted at a minimum of three (3) feet tall and reach the height of at least eight (8) feet within three years and shall be maintained in good condition. Failure to maintain the buffer shall constitute a violation of this ordinance. Earth-berms, other topographical features and existing wooded areas may be accepted in lieu of the above requirements, if they conceal the use from public view and are maintained.
 4. Lighting: If lighting is provided at the site, lighting shall be shielded and downcast such that the light does not spill onto the adjacent parcel or the night sky. Motion sensor control is preferred. all lighting shall be arranged and shaded so as to reflect the light away from adjoining properties and streets.
 5. Noise: Noise levels measured at the property line shall not exceed fifty (50) decibels when located adjacent to an existing residence or residential district.

6. Power Transmission Lines: To the extent practical, all new power transmissions lines to any building, structure or utility connection shall be located underground. Existing above ground utility lines shall be allowed to remain in their current location.
7. ~~Approved Solar Components~~ Installation and Design: Electric solar system components must have a UL listing and must be designed with anti-reflective coating(s). Individual arrays/solar panels shall be designed and located in order to prevent glare toward any inhabited buildings on adjacent properties as well as adjacent street rights-of-way.
8. Compliance with Building and Electrical Codes: All solar farms shall be in conformance with the requirements of the State Building and Electrical Codes (current addition), the State of North Carolina and Vance County. All active solar systems shall be inspected by a Vance County building inspector.
9. Inspections: Each solar farm shall be required to have the facility inspected annually for 3 years following the issuance of the zoning permit to verify continued compliance with the Zoning Ordinance. Additional inspections necessitated by complaints or otherwise shall not replace the annual inspection requirement.
10. Utility Notification: No grid tied photovoltaic system shall be installed until evidence has been given to the Planning and Development Department that the owner has been approved by the utility company to install an interconnected customer-owned generator. Off-grid systems shall be exempt from this requirement.
11. Abandonment and Decommissioning: It is the responsibility of the solar system owner and landowner to notify the County and to remove all obsolete or unused systems within twelve (12) months of cessation of operations. Reusable components are to be recycled whenever possible.

A decommissioning plan signed by the party responsible for decommissioning and the landowner (if different) addressing the following shall be submitted with the permit application.

- a. Defined conditions upon which decommissioning will be initiated (i.e. end of land lease, no power production for 12 months, etc.)
- b. Removal of all non-utility owned equipment, conduit, structures, fencing, roads, and foundations
- c. Restoration of property to condition prior to development of the solar farm.
- d. The timeframe for completion of decommissioning activities.
- e. Description of any agreement (e.g. lease) with landowner regarding decommissioning.
- f. The party currently responsible for decommissioning.
- g. Plans for updating this decommissioning plan.

C. The above amendments are effective upon adoption of this ordinance.

Re: 2015 Summer Work Program

The Summer Work Program began June 22, 2015 and ended August 14, 2015 with seven students (Northern Vance High School – 2; Southern Vance High School – 2; Western Vance High School – 1; Early College High School – 1; and Vance Granville Community College, IT Dept. – 1). The Program was successful for Vance County and the students. Students gained data entry and web-based research experience, responsibility, and self-confidence while being paid an hourly wage. Departments gained help with research, data entry, and extra hands that allowed regular staff time to work on special projects.

When asked “what was the biggest impact this experience had on them”, the students replied in their own words:

- added responsibility
- would like to go to VET School
- patience and stepping outside the box
- being able to work with different people
- the experience of a job
- gained self-confidence
- validating current knowledge and realizing there is still much to learn

Each student would like to see this program continued for rising seniors during the same time frame.

The Departments benefitting included the Senior Center, Cooperative Extension, Information Technology, Animal Control, and Maintenance.

All Department Supervisors gave high ratings on their evaluations (ranging from a 3 for Average to a 5 for Excellent). Areas that received a 3 included Understanding Broader Issues and Oral and Written Communication, while other areas from Ability to Complete Tasks, Ability to Organize, Making Decisions, Effective Use of Time, and Following Instructions ranked 4's and 5's.

All of the student workers are potentials candidates for hire by their evaluating supervisor. The supervisor would also like to see this program continued yearly.

This program was a win-win for everyone. Thank you, Commissioners, for the desire to launch such a program and allocating the funds to make it happen.

Vance County Board of Education intends to file an application for approval of a guaranteed energy savings performance contract to the NC Local Government Commission (LGC). The purpose of this contract is to reduce energy consumption and improve efficiency throughout the school district, as referenced by N.C.G.S. 143.64.17. The resolution is in support of the school district's infrastructure improvements through savings.

The following are the majority of the major Energy Conservation Measures to be implemented through the guaranteed energy savings performance contract:

All schools in the Request for Proposal (RFP)

- Interior and exterior LED lighting upgrades

Water Conservation at select sites

Note: Lighting and Water energy conservation measures (ECMs) help fund the other projects listed below.

14 Facilities

- New web-based/wireless Building Automation System (BAS)
- This system will tie the existing controls to the new controls in a single window. The foundation will be in place to allow other systems (i.e. security) to be added in the future.

Plug Load Controllers

All schools in the RFP

- Building Envelope / Weatherization

Southern Vance High School

- Replace 2 chillers
- Variable Air Volume (VAV) Conversion – this will improve comfort and increase efficiency at the school

Heat Pump Replacements (*Per Alysa in today's meeting*)

- Currently, New Hope is included in the project; however, we are awaiting the interest rate to determine how much of E.M. Rollins can be included in the project. This is why the resolution states a Not To Exceed contract amount.

RESOLUTION
by the

*Acknowledging the Execution and Delivery by the Vance County
Board of Education of a Guaranteed Energy Savings Contract*

BE IT RESOLVED, by the Board of Commissioners (the “Board”) of the County of Vance, North Carolina (the “County”) as follows:

1. The Board hereby finds, determines and acknowledges that:
 - (a) the Vance County Board of Education (the “School Board”) plans to enter into an energy savings contract pursuant to G.S. 143-64.17 et. seq. for the purpose of providing certain energy conservation measures authorized thereby (the “Project”) so as to reduce energy consumption and/or energy-related operating costs; This project is a fixed priced, turnkey project that is self-performing and will not exceed the amount of \$6.8 million dollars.
 - (b) the School Board intends to finance the Project by entering into an installment contract (the “Contract”) pursuant to G.S. 143-64.17C and G.S. 160A-20, as amended;
 - (c) the energy savings resulting from the Project are expected to equal or exceed the total costs payable under the Contract as shown in an evaluation performed by the engineering firm Advanced Energy on behalf of the School Board;
 - (d) the payments under the Contract are not expected to require any additional appropriations to be made to the School Board nor any increase in taxes; and
 - (e) the Board does not intend to reduce appropriations to the School Board based upon a reduction of energy costs in a manner that would inhibit the ability of the School Board to make the payments under the Contract, provided that the County is not bound in any manner to appropriate funds to the School Board in amount sufficient for the School Board to make such payments.

Committee Reports and Recommendations

Water Planning Committee

Monthly Construction and Operations Reports. This committee (Garrison [C], Taylor, Brummitt) met Monday, August 31 to review the monthly operational reports as well as to review an extended warranty for the bore at Rock Mill Road and Sandy Creek (Phase 1A), and to provide guidance on the final adjusting change orders for Phase 2A. Staff informed the committee that the greatest priority during the past month has been getting all of the waterlines in the ground to meet the deadline of September 15 imposed by USDA. While this has been a challenging timeline, as of September 3, all of the piping has been installed and testing efforts will be taking place during the next two weeks. Staff informed the committee that significant cleanup is necessary and will be completed over the next few weeks. The staff and crews have been very busy over the last month responding to citizens and addressing the areas in greatest need of cleanup. Regarding the operational reports, a committee member noted the importance of determining methods to recover the availability fees that are greater than 90 days overdue. Staff will be working on another round of the debt setoff process in the fall and early 2016 in this regard; however, additional methods need to be considered with the assistance of the County Attorney. Extended Warranty – Rock Mill Road/Sandy Creek Bore. The committee met with the contractor (H.G. Reynolds) during its July meeting to discuss contractual matters related to an extended warranty/bond for the Rock Mill Road bore at Sandy Creek. Previously staff has met with the contractor and used direction from the committee in establishing a point for negotiation. During the meeting between the committee and the contractor, the negotiation continued to a point where terms of a three-year extended warranty/bond were agreed upon. The committee feels that a bond is necessary to assist in alleviating concerns following the installation which occurred in September 2013 and subsequent break of the line in March 2014. Following an investigation by the engineer as well as Envirolink, it was determined that the subcontractor attempted to install the bore under the creek as specified, and as a result of encountering rock proceeded to bore the line along an alternative route in the shoulder of the roadway without proper approval of the County, engineer, or the Department of Transportation. Since that time, the engineer, NCDOT, and NCDENR have approved and certified the line in its current location. The committee recommends the extended warranty and bond to close the matter and to allow Phase 1A to close out. [***Recommendation: Approve warranty bond with H.G. Reynolds providing an extended warranty of three years beyond the standard warranty for the bore located at Rock Mill Road and Sandy Creek.***](#)

Final Adjusting Change Orders – Phase 2A Contract 2. The committee reviewed the budgets for Phase 2A and 2B in order to recommend approval of the final adjusting change order for the remaining contract in Phase 2A. Previously, the Board approved final adjusting change orders for all other contracts within Phase 2A and 2B and has left the remaining contract open to allow the final road additions to be completed. USDA has imposed a deadline of September 15 for all work to be complete and will be closing out the funding by September 30. As a result of this, it is necessary for the Board to approve the remaining adjusting change order. From a review of the budgets, it is anticipated that \$275,000 in Phase 2A and \$859,000 in Phase 2B grant funds will be returned to USDA. The County is in discussions with USDA and believes they are willing to provide an additional grant of up to \$1 million which would be used to complete Rock Mill Road, NC 39 Hwy South to Foster Road, and Foster Road in 2016. The committee recommends approval of the final adjusting change order from Phase 2A, Contract 2.

Recommendation #1: Approve final adjusting change order for Contract 2 in Phase 2A with Hawley Construction.

Water System Overview:

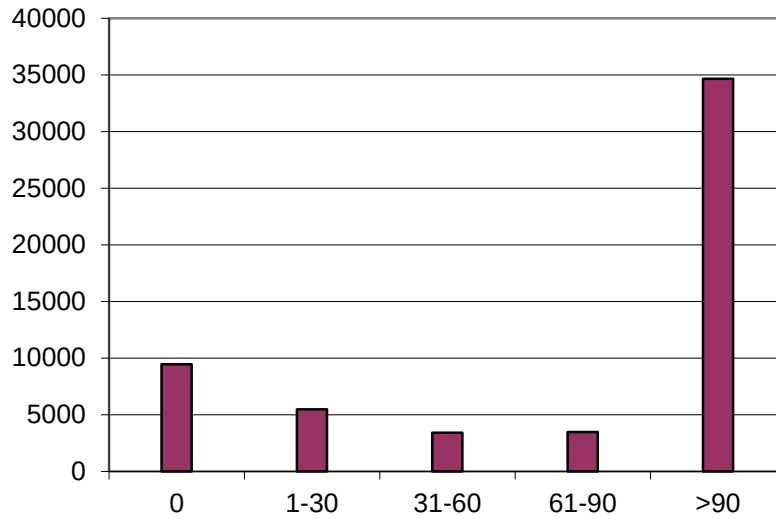
Customer disconnection letters were compiled on 08/13/2015 and mailed for a shut off date on August 27, 2015. The current customer count in Phase 1A is 222 availability accounts and 418 metered accounts. The current accounts in Phase 2 is metered 127, availability accounts 146.

Water services installed in Phases 2A and 2B is 279 connections; in Phase 2A, 173 services installed, in Phase 2B, 106 services installed. The signups in new road additions in Phase 2A is 90 and in Phase 2B is 99. There is a total of 1178 customers committed to the water system countywide.

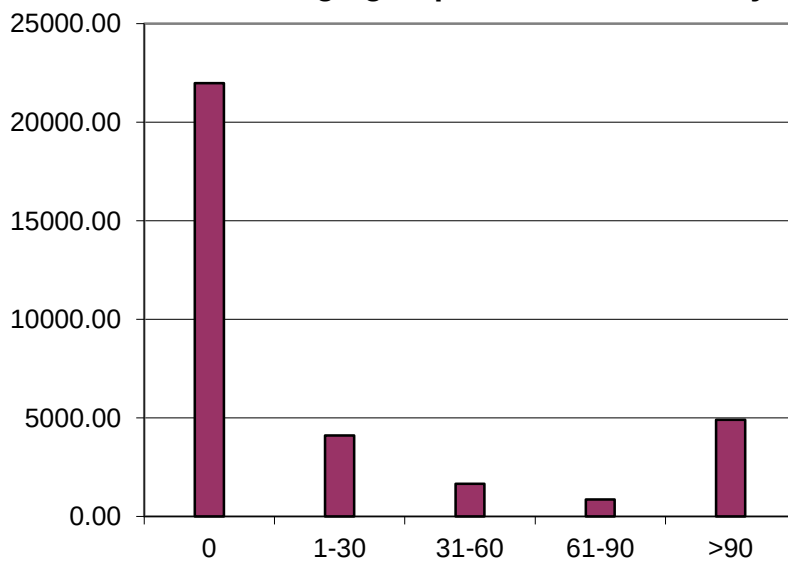

WARRANTY BOND

KNOW ALL BY THESE PRESENTS, That we, H.G. Reynolds Company, Inc., Henderson, NC, as Principal, and Liberty Mutual Insurance Company, a corporation organized under the laws of the State of Massachusetts and duly authorized to do business in the State of North Carolina, as Surety, are held and firmly bound unto the Vance County Water District, Henderson, NC as obligee, in the penal sum of **Two Hundred Thirty Three Thousand Seven Hundred Fifty Eight and 00/100 DOLLARS (\$233,758.00)** to which payment well and truly to be made we bind ourselves, our and each of our heirs, executors, administrators, successors and assigns jointly and severally, firmly by these presents.

WHEREAS, the Principal entered into a contract with the said Obligee, dated May 12, 2012 for Phase IA Contract 2 which contained a segment of the project known as: Line Item 14; 14" DRP HDPE Sheet W11.13 Station 161 + 50 to 165+00.

Committee Reports and Recommendations

September 8, 2015

Human Resources Committee

Position Vacancies. (A) The Department of Social Services has a position vacancy for a *Social Worker I*. It is essential to the department to fill this position to ensure the services to residents of Vance County are not hindered, as an employee in this position can assess up to 18 clients in a single work day. (B) The Department of Social Services has a position vacancy for an *Income Maintenance Caseworker II*. This position is critical to meeting program standards and ensures quality services are provided for needy families in Vance County. (C) The Department of Social Services has a position vacancy for a *Social Worker III*. This position is essential to the department and provides protective services to vulnerable adults in the community. (D) The Jail has a position vacancy for a *Detention Officer*. This position ensures the safety and security at the Vance County Detention Center. (E) The Sheriff's Office has three (3) position vacancies for *Deputy Sheriff*. These positions are essential to perform general duty law enforcement work to protect life and property in the County. (F) Emergency Operations has a position vacancy for a *Telecommunicator I*. This position is critical to adequately process calls from the public and handle call volume from the public safety agencies. (G) Emergency Operations has a position vacancy as a *Training Supervisor*. This is a critical position that tracks training records and certifications as well as provides ongoing training to seasoned Telecommunicators and basic training to new hires. *[Recommendations are contingent upon endorsement by the Human Resources Committee.] Authorize the filling of the vacant positions as requested.*

Public Safety Committee

Review of Animal Shelter Plans and Timeline. The committee (Brummitt [C], Brown, & Wilder) met Wednesday, August 19 to review the final building and site plans for the animal shelter prior to submitting to USDA for authorization to bid the project. The committee was made aware that a sewer pump system will be necessary to pump from the Brodie Road side of the property to the Julia Avenue side of the property due to elevations. Staff has followed up with the City of Henderson and it is apparent that a small pump system is necessary. While not anticipated originally, it is believed that this can be covered within the existing USDA project budget. The project architect will be releasing the project for bids as soon as authorization is received from USDA. The updated budget projections and timeline are attached. *For Your Information.*

Tax Revaluation Ad-Hoc Committee

Revaluation Timeline and Public Education Update. The committee (Brummitt [C], Garrison & Brown) met Monday, August 31 to review the revaluation timeline and to receive an update on public education efforts. The Tax Administrator informed the committee that informational letters were included in the recent mailing of annual bills, a Q&A has been added to the County website, and an informational brochure will be distributed at various locations during the month of October. A copy of the timeline inclusive of planned educational efforts is included in the agenda materials. The committee discussed the appeal process which will take place between February and April 2016 and discussed the importance and timing for communicating the concept of revenue-neutral. The committee felt that the ideal time to provide information on revenue-neutral would be to include information with the assessment letters to be mailed out in February 2016. *For Your Information.*

Properties Committee

Offers to Purchase REO Properties. The committee (Brown [C], Brummitt & Hester) met Tuesday, September 1 and reviewed three offers to purchase property owned by the County and one offer to purchase property owned jointly by the City and County as a result of foreclosure. The offers were as follows:

- NC Hwy 39 North (Tax Parcel 0365 02045) - \$1,500 (County Owned)
- Woodsworth Road (Tax Parcel 0303 02005) - \$1,500 (County Owned)
- Orr's Lane (Tax Parcel 0404 03025) - \$1,100 (County Owned)
- 152 South Bullock Street (Tax Parcel 0085 01011) - \$750 (City/County Owned)

Following a review of the offers, the committee recommended proceeding with the upset bid process for the first property located off of NC Hwy 39 North. It is hoped that opening this property up with an access road may lead to other property development in the area. In addition, the committee established counter offers for the Woodsworth Road and South Bullock Street properties that would cover the County costs and uncollected taxes for the properties. The committee did not provide a counter offer for the Orr Lane property and believes another pending foreclosure in the immediate area could be combined with this land and draw more attractive offers in the future. ***Recommendation:*** *Approve resolution authorizing the upset bid process for the sale of tax parcel 0365 02045 located off of NC Hwy 39 North.*

Update - Building Needs Assessment and Space Study. Staff informed the committee that they have reached out to other architects and are awaiting their proposals. Once received, the committee will review and advise the full Board on the best way to proceed. *For Your Information.*

Demolition of REO Properties. The committee reviewed the listing of County REO properties and focused their discussion on 11 properties with structures in need of demolition. Staff has applied for grant funding from the State's abandoned mobile home program and believes that six of the 11 properties can be handled at minimal cost with those funds. Regarding the remaining six properties, it is anticipated that demolition could cost approximately \$17,500. The majority of committee members would like to take a phased approach utilizing the existing budgeted funds this year to carry out the abandoned mobile home program and to demolish one other structure. The committee will then revisit the other properties later in the fiscal year when better revenue projections are available. The committee prioritized one property for immediate demolition (1335 Epsom Road) due to its location near the new charter school and also as a result of the potential for drawing unwanted activity to the property. Staff will be proceeding with the solicitation of quotes for the demolition of this structure. *For Your Information.*

Marketing of REO Properties. The committee discussed marketing strategies for the remaining County REO properties and was made aware that staff is working to list the properties on the County website. The committee discussed the potential for listing the properties on GovDeals which is an internet auction site used by many counties throughout North Carolina to dispose of surplus property and real estate property. The committee believes this is a viable option for marketing the properties and will be receiving additional information from GovDeals in the coming weeks. Additionally, staff and the committee discussed the need for establishing a minimum bid amount for each property prior to listing the properties and will send letters to surrounding property owners once a minimum bid amount is established by the committee. *For Your Information.*

Vance County EMS has an opportunity to purchase three Autopulse boards at a deeply discounted rate. These units typically cost between \$15,000-18,000 and we have an offer from a vendor to purchase three demo units at a cost of \$8,500 each. The vendor is working to secure a fourth board at a comparable price so that all of our EMS units will be outfitted equally. Autopulse boards are used to deliver chest compressions to a patient during a cardiac event. The boards deliver a more consistent compression rate than when performed by a medic. Use of the board also frees up the medic to administer other care while the machine delivers chest compressions to the patient.

Recommendation: Approve budget amendment allocating \$34,500 for the purchase of four Autopulse boards to outfit all Vance County EMS units.
